The shirt must have some kind of design/logo/picture on it. **THIS IS YOUR OPPORTUNITY TO LIFT FOR THE PRICE OF GETTING RID OF THAT STRANGE THING IN YOUR CLOSET.** If a relative has not provided you with something suitable, you'll have to brave the retail market. **Your entry fee t-shirt must be presented at weigh-in in order to weigh-in and lift.**
